Extension to existing rear dormer to facilitate first floor habitable  
accommodation; roof alterations

**17/00984 – Mr & Mrs Davies, Lanreath, Hatchet Close, Hale, SP6 2NF  
Single storey rear extension; demolition of existing conservatory

Following a discussion and consideration of a letter from a local resident in support of the application Cllr Templeton proposed and it was seconded by Cllr Harrington and therefore **RESOLVED**: to adopt option 3, to recommend permission for the following reasons:

- The design is an improvement on existing building
- It is supported by a local resident
- It complies with DP11

**17/01000 – Dr & Mrs Jameson, Delmore, Hale Road, Hale, SP6 2NW**  
**Single storey extension; single storey infill extension; loft conversion to form habitable accommodation; 13no. rooflights; cladding; 3 bay garage/log store (Demolition of existing conservatory)**

**Consultation period expires: 28 December 2017**

This application was considered at length without the benefit of the case officer's report. It was noted that the plans lodged on line had been amended from those originally submitted and considered by Members in hard copy. Members have the following concerns:

- previous alterations may mean this application is in breach of DP11 but it is not possible to do the calculation from the information available.
- difficulty in clarifying the amended plans, there appears to be no stair access to the loft void
- the proposed triple garage is far too high and too large and will dominate the site.

Cllr Aitken-Sykes proposed and it was seconded by Cllr Harrington and therefore **RESOLVED**: to adopt option 2, to recommend refusal for the reasons listed above but to accept the decision reached by the National Park Authority's Officers under their delegated powers. Cllr Templeton agreed
